Eligibility

The Styers Family Feed & Supply Wildlife Sweepstakes (SFFSWS) is open to all persons who are legal residents of the 50 United States and District of Columbia, who are at least 18 years old at time of entry. Void outside the USA, in Puerto Rico, the US Virgin Islands, and other United States territories and possessions. Sponsorship

Limitations on Entries

Drawing

SFFS reserves the right to disqualify any entrant or winner and may refuse to award a prize to a person who is not eligible or has violated a rule, gained unfair advantage in the SFFSWS, or obtained winner status using fraudulent means. If there is a dispute about the identity of an entrant, prize will be awarded to the person to whom the SFFS account or Facebook account belongs to. If winner is found to be ineligible or not in compliance with rules, winner will be disqualified and an alternate winner will be awarded the prize in a
